
I am directed to refer to the subject noted above and to state that the payment for the hiring of manpower for handholding charges for two years under the scheme of Computerization of records of State Waqf Boards has been reviewed and it has been decided that in the **nineteen (19) State/UT Waqf Boards of Andhra Pradesh, Bihar (Sunni), Chhattisgarh, Delhi, Gujarat, Haryana, Himachal Pradesh, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Orissa, Punjab, Rajasthan, Tamil Nadu, Uttar Pradesh (Sunni), Uttar Pradesh (Shia), Uttarakhand and West Bengal, the deployment of one (1) System Analyst and three (3) Data Entry Operators (DEOs) will be permitted.**

2. In place of a System Analyst, the Assistant Developer already working in the State Waqf Board should continue to be deployed to allow continuity of work during the handholding period of two years.

3. The Assistant Developer who is presently being paid Rs. 15,000/- per month, will now be paid Rs. 17,500/- per month for the first year and Rs. 20,000/- per month in the second year of the handholding period of two years.

5. A Data Entry Operator who is presently being paid Rs. 10,000/- per month, will now be paid Rs. 12,500/- per month in the first year and Rs. 15,000/- in the second year of the handholding period of two years.


