Subject: Unique I.D. for each Waqf Property and Aadhar Number of its
Muttawali/Managing Committee Members.

Sir,

As you are aware, this Ministry has launched a Plan Scheme of "Computerization of the records of States Waqf Boards" to streamline record keeping, introduce transparency, and to computerize the various functions/process of the Waqf Board and to develop a single web based centralize application. An On-line system named WAMSI has been developed for entering the details of the waqf properties.

2. Under this project, the unique Waqf ID is allotted to every Waqf Estate in the country by which Waqf Properties are identified in the WAMSI On-line System. The monitoring of these Waqf Properties managed by muttawalis/managing committee can be done on the basis of this unique Waqf ID. Further, the activities of Mutawalli/Management Committee can be monitored on the Public Interface of WAMSI On-line System viz. filing of the Annual Return, Income & Expenditure shown in the Annual Return, Administrative Contribution paid, whether fully paid or partly paid, the welfare measures taken during the Year etc.

3. It may be mentioned that while reviewing the progress of this Ministry, Hon'ble Prime Minister stressed upon the need to digitization of waqf records and mapping of waqf properties through GPS. The records of waqf properties are to be seeded with unique Aadhar number of Mutawalli/Management Committee etc. It is informed that WAMSI On-line System Modules have provision of Aadhar Number.

4. State/UT Waqf Boards are requested to take necessary action to update the records of waqf properties, link the I.D. of waqf property with Adahara Number of Muttawali/Management Committee etc. The Muttawalis who do not have Aadhar Number should be asked to take it immediately.

5. To bring improvement in income generation and attaining self sufficiency and reduce dependency on outside financial support, Government of India has formulated another Plan scheme for strengthening of State Waqf Boards. The guidelines of the scheme have already been circulated to all concerned. NAWADCO has been designated as the Implementing Agency. Component II of this scheme is regarding GPS mapping of the waqf properties. This would help in identification and removal of encroachment from the waqf properties.
